ABLEnow is an Internal Revenue Code Section 529A qualified ABLE program. A Section 529A ABLE account is an individual savings account for eligible individuals with certain disabilities intended specifically for the payment of qualified disability expenses. For residents of states other than Virginia: your state of residence may sponsor an ABLE plan that offers state income tax or other benefits not available to you through ABLEnow.

1. ABLEnow account owner must be a U.S. citizen or legal U.S. resident 18 years old or older at time of account opening (or have an authorized representative) and meet all eligibility requirements to open an ABLEnow account set out in the ABLEnow Program Description and Custodial Account Agreement.
2. ABLEnow account must be in good standing at time of entry to enter Sweepstakes.
3. ABLEnow account owner (or authorized representative) must complete the online ABLEnow Ambassador application and complete the application requirement to email a photo.
